Situation

- The humanitarian impact of COVID-19 on refugees and migrants from Venezuela continues to be tough and disproportionate, since most of them have lost their jobs and livelihoods. Many are lacking shelter, food and money to pay for their basic needs, while others are confronted with homelessness.
- Refugees and migrants also face difficulties accessing social programmes due to • lack of documentation and/or not complying with requirements related to the length of their residence in these countries.
- Movement restrictions were partially lifted in all of four countries, mostly in • Paraguay and Uruguay, while stricter measures remained in place in main urban centres of Argentina and Bolivia. Borders in the four countries remain closed.
- Partners became aware and provided emergency assistance to refugees and • migrants from Venezuela who tested positive with COVID-19 in Bolivia and Argentina, complementing national support services.

- Some refugees and migrants approached partners in Argentina and Bolivia requesting assistance to return to Venezuela, reflecting the dire situation in which they have been living over the past two and a half months due to the pandemic.
- Representatives of the governments of Argentina, Bolivia, Paraguay and Uruguay attended the Pledging Conference in solidarity • with Venezuelan refugees and migrants on 26 May, co-organized by the EU and Spain, Canada and Norway with the support of UNHCR and IOM, adressing the donor community and showing their commited support in the search of solutions for refugees and migrants from Venezuela in the sub-region.



- Assistance provided by partners continued to be focused on providing shelter solutions, NFIs (especially medicines and hygiene, baby and maternity kits), food assistance and cash-based interventions to the most vulnerable refugees and migrants from Venezuela in border areas and in the main urban centres, where most of the population is located.
- Moreover, primary health care assistance, psychosocial support, as well as interventions targeting children's education have been scaled-up in Bolivia and Uruguay.
- As the winter approaches in the Southern hemisphere, partners have begun providing assistance for refugees and migrants to cope with low temperatures, such as winter kits and hot meals. Low funding puts the continuity of the assistance at risk, especially as some quarantine measures remain in place in most of the countries.

- As days in lockdown continued to increase, partners identifed and provided socio-legal assistance and support to GBV cases in Argentina and Bolivia.
- Partners in Bolivia continued monitoring the situation at borders and advising Venezuelans on the risks of attempting journeys under the current circumstances, as several attempts of irregular crossings were reported.
- Partners are providing assistance for the socio-economic integration of refugees and migrants from Venezuela, including micro-entrepreneurship support, counselling and dissemination of job vacancies.
- Partners have also continued collecting key information on short and medium term needs of refugees and migrants in the subregion, including opportunities to mitigate the negative socio-economic impacts of the compulsory social isolation.
